

Rules & Regulations

- 1) **FLUID ENTERTAINMENT & PRODUCTIONS** reserves the right to deny vendors access to any event if **Fluid Entertainment, Inc or its subsidiaries** feels that participation by a group or individual will harm the event or **Fluid Entertainment, Inc. or its subsidiaries** in any manner. **Fluid Entertainment, Inc. or its assignees**, will be the final arbiter in these cases.
- 2) **Payment Policy:** All exhibit fees are due with application. Exhibit space will not be confirmed until full payment and Tax ID has been received.
- 3) **Cancellation Policy:** Full refund minus \$250 administrative fee will be processed if cancelled, in writing, before May 31, 2010. 50% refunds will be processed if cancelled, in writing, from June 1, 2010 thru June 30, 2010. No refunds will be made after June 30, 2010.
- 4) **Exhibitor Badges:** All Exhibitor badges will be distributed during registration. Each tabletop includes 2 complimentary registrations which provide access to exhibit hall and Q&A sessions on exhibit days only. Badges are non-transferable.
- 5) **Additional Badges:** Exhibitors may purchase additional badges which provide access to the exhibit hall and Q&A sessions on exhibit days only for \$500 each. **Purchased registrations are non-refundable.**
- 6) **Sale of Merchandise:** **Fluid Entertainment, Inc. and its subsidiaries** only allows the sale of licensed merchandise at the MJ Fanvention™2010. Exhibitors are responsible for the legality of the items they sell, as well as government and/or tax licenses, and insurance.
- 7) **Prohibited:**
 - a. Sale of any merchandise or materials deemed to be pornographic
 - b. Distribution of any promotional materials not related to MJFanvention™2010 is strictly prohibited.
 - c. **Fluid Entertainment, Inc. and its subsidiaries** reserves the right to prohibit the display and/or sale by any exhibitor of merchandise that it deems inappropriate, offensive, or illegal. The decision of the producer is final.
- 8) **Private Meeting/Game Rooms:** Exhibitors wishing to host hospitality suites, business meetings, etc. at the Radisson Hotel at Star Plaza, must make such requests in writing, to Fluid Entertainment, Inc. P O Box 11814, Merrillville, IN 46410.
- 9) **Press Functions:** Companies exhibiting at MJFanvention™2010 may schedule press briefings throughout the duration of the Fanvention™. Contact Fluid Entertainment, Inc. for details.
- 10) **Hold Harmless:** Exhibitors agree to hold harmless **Fluid Entertainment, Inc. and its subsidiaries**, and any of its production partners from loss, theft, damage of merchandise or injury sustained during attendance at MJ Fanvention™2010.
- 11) **Exhibit Hall Security:** **Fluid Entertainment, Inc. & its subsidiaries** will hire security to secure exhibit hall during non-show hours. **Fluid Entertainment, Inc. and its subsidiaries** takes no responsibility for items lost or stolen during these hours. It is the Exhibitor's sole responsibility to remove all valuables during non-show hours. It is also the Exhibitor's responsibility to carry adequate insurance for their merchandise.
- 12) **Sublet or Lease:** Exhibitors are not allowed to sublet or lease their exhibit space to any other individual or company.
- 13) **Tax ID:** All Exhibitors must have a valid Tax ID number in order to sell any merchandise on exhibit floor. It is the Exhibitor's responsibility to obtain this Tax ID. **Tax ID is required when submitting application.
